## **OEN April 27<sup>th</sup> 2015 Nomination Business Meeting Minutes**

- 1. W7WX, the OEN Board Chairman, called the meeting to order using the W7OEN club call at 1915 PDT. He stated that this is an official OEN business meeting then turned it over to AG7K.
- 2. AG7K then called the board members call signs one at a time to see if they are present.

- 3. - 6. W7WX/W7OEN opened the floor to nominations for SW director. KE6NVU nominated K7KY. K7SEG is running as the incumbent.
- 7. W7WX/W7OEN asked the nominees if they intended to run and they signified by voice in the affirmative. They were also asked to submit an email ASAP to AG7K at W7OEN1@gmail.com verifying

in writing that they intend to run. He also stated that the voting would commence on May 1<sup>st</sup>, 2015. The election will be closed 15 days after it starts and the ballots counted.
