OEN SPECIAL MEETING OF THE BOARD JULY 15th, 2008

The Net Manager called the meeting to order at 5:55pm. Board Members present were K7JUC, K7SEG, KB7JAL, K7MKN, N7IPG, & W7BXD. The purpose of this meeting was to appoint a Director at Large and a Chairman of the Board that was previously held by K7DDI who resigned on July 11th, 2008. The Director at Large will be appointed until 2010, at which time the position will be up for re-election. WA7FIV, Hal from Seaside volunteered to fill that position. All Board Members approved of the appointed position being filled with WA7FIV, Hal of Seaside. The next position open was Chairman of the Board, and K7MKN had stepped up to take this position. K7MKN was approved by all Board Members to become the new Chairman. Net Manager then turned the meeting over to the new Chairman to see if he had any comments. OPERATION RATTLER --On July 16, 2008 The Klamath County RACES/ARES team participated in "Operation Rattler" which ran from approximately 7:30 am until 10:00 am. Operation Rattler was originally an External Field Exercise for TransCanada.(pipeline) The exercise expanded to include: Klamath County Fire District 4 and 5 State Fire Marshal, HAZMAT, Oregon Department of Forestry, Klamath County RACES/ARES for Klamath County Emergency Services Agency; amateurs participating, WA7YPR, K7DDI, KE7BQM, AB7ET, ND7V, KC6ISC, KJ7YB, K7RFO. We Operated on 146.44MHZ simplex with two relays via WinLink to OEM. We Operated on 3.964 MHZ SSB with W7OEM and used the HF for a second frequency for the local net. The Operation was located NW of Bonanza OR. The Scenario was that a D8 cat contacted a 42 inch natural gas line causing a gas leak which ignited immediately. The operator was killed instantly and two laborers were injured. There were simulated Ambulance runs, Simulated Air Ambulance runs, Oregon Department of forestry simulated at least two water drops for fire suppression. Without notice the evaluators announced that a power transformer blew causing the power company to simulate shutting of the power to the area and O.D.F to simulate fire suppression in the surrounding area. As things were moving the evaluators asked a firefighter to simulate a collapse, The ambulance had to respond to that also. TransCanada activated their EOC in Spokane Washington and had about 6 people on the scene. Klamath County Fire

(3) Districts 4 and 5 had about 20 volunteers on scene with about Fire engines and water tenders. By Dennie WA7YPR (Thanks to Dennie for sharing, Dennie is the ARES EC for Klamath County) –ed)

5 OREGON EMERGENCY NET MINUTES August 17th, 2008

The meeting was called to order by the Chairman of the Board K7MKN. The minutes were read and accepted as read. Fred, ND7V said he had the treasures report from Joe, K7NLM but had forgot to bring it so will give it to the Secretary, N7RBO when he gets home so the information could be added to the minutes.

N7IPG, Warren brought up that the OEN booklet wasn't being followed, the way that the excused stations were being done was not the way it should be handled, also the same on the solid stations. Ruth, K7RFO mentioned the book was written in 1949 and things then didn't pertain to today and was used mostly for a Guide Line. K7MKN made a motion that N7IPG update the booklet and 2nd by WA7FIV. Warren N7IPG said he would accept the job but there couldn't be any timetable for the completion.

K7DDI suggested that we have three people on the check-book instead of two, so the funds could be secured in case of loosing any other signature holders on the account. He made a suggestion of the Secretary or any OEN member. The secretary N7RBO declined saying she has too many positions already. ND7V is going to look into the matter, like what bank is used and the other information needed. ND7V is actually the only one that receives funds from the account and he said he wouldn't mind being added. The issue was tabled until more information was collected, and then will be reviewed again next year.

K7MKN asked KK7VO & K6UGS if they could update the information like e-mails, phone numbers and addresses on their websites. Some of the information has changed and the correct information should be available to all OEN Members. K6UGS said he only posts the roster and minutes the reason was not to take anything away for the original OEN web page.

K7RFO wanted to emphasize that this was friendly net not a military net and it should stay this way. If too many regulations were put in place people would be discouraged and not check in. N7RBO said that we have increased our check-ins 900 to 1,000 a month from this time last year.

KG7UY ask if it okay with the Board that he asks the Oregon State Defense Force to check in at the beginning of the net, all the Board approved. Dennis was in agreement that all Net Controls be in control of their own net.

With no other business K7MKN ask for a motion to adjourn the meeting, W7BXD made the motion and was 2nd by WA7FIV. The meeting was adjourned at 2:05 PM.
